you wanted to talk to your doctor about. If the insurance company finds something in your medical past that would embarrass you, they certainly may use that information to their advantage. **Frankly, I don't like the idea that the insurance company gets "CHUMMY" with the treating doctors.** I don't like the idea that insurance companies can have *private conferences* with your doctors and **you don't even know.** If you have already signed a Medical Authorization for the insurance company, **I can get it canceled within 72 hours.** There may be a lot of information about you in your medical records that is personal and has nothing to do with your current injury. Why should the insurance company have the right to this information?
